Upon arriving in the destination country, they were trafficked for forced marriage, sexually, physically, and psychologically abused, and forced into childbearing for a foreign family. TRAFFICKING INDICATORS:

- ▶ Job offers that seem too good to be true, offering extremely high pay or benefits for relatively low-skilled work.
- ▶ Vague job descriptions, unclear responsibilities, and missing details about the employer, location, and working conditions
- ▶ The employer or recruiter demands money from job seekers for recruitment, visa processing, or placement fees,
- ▶ Employers or recruiters who misrepresent the nature of the job, the working conditions, or the destination can be involved in human trafficking.
- ▶ Employers or recruiters who confiscate or withhold passports, identification documents, or visas can attempt to control and exploit workers.
- ▶ Job offers that include living and working in remote or isolated locations with no freedom of movement can be suspicious.
- ▶ International relocation promises a better life, but no clear information about the destination or living conditions exists.
- ▶ Contracts that lack essential information about wages, working hours, overtime pay, and other employment terms can be a sign of potential exploitation.
- ▶ Job offers that require workers to move to a country where they do not speak the language or understand the culture can be problematic.
- ▶ No choice of accommodation
- ▶ Offers that target minors for employment, especially in hazardous or inappropriate conditions
- ▶ Job's advertised in an area that is susceptible to trafficking
- ▶ Involves travel to another location, often to a different country, sometimes with other unknown persons
- ▶ Lacks substantial details about the recruitment agency or employer and the anticipated work, limited or no information about the destination or address of the workplace
- ▶ The company is using free email addresses (e.g., Gmail/Yahoo)
- ▶ The intermediary company pays all the transport expenses
- ▶ There is no requirement to speak a foreign language
- ▶ There is no contact person mentioned or/and any contact information about them

SOME SIGNS THAT SOMEONE COULD SOON BE (OR IS ALREADY) A VICTIM OF FORCED MARRIAGE:

- ▶ Running away from home
- ▶ A surprise engagement to a stranger you've not heard of before
- ▶ Not returning from a visit to another country
- ▶ Physical and Psychological Abuse
- ▶ Victims may be subjected to exorbitant recruitment fees or debt bondage, which they are forced to repay through labor.
- ▶ Language and Cultural Barriers make it challenging to seek help.
- ▶ Confiscation of Earnings
- ▶ Lack of Personal Documentation
- ▶ Underage Victims:
- ▶ Living and working in locked premises, with limited freedom of movement.
- ▶ Inadequate food and healthcare
- ▶ Restricted access to phones or the internet
- ▶ Victims are often subjected to threats, intimidation, and manipulation to keep them compliant and afraid to seek assistance.
